Through a cooperative agreement with USAID, AYA implemented a clean water and sanitation project to reach 29 communities in Uganda. Activities for 2010 included survey of needs, meeting with community leaders, forming water committees, conducting community trainings on water safety and hygiene, collecting baseline data, and completing 18 water projects to include wells, rainwater harvesting, protected springs and borehole repair.

4b (Code:) (Expenses \$ 22,345 including grants of \$ 22,345) (Revenue \$ 0)

The grant went to Sandota Primary in Nairobi, Kenya for school construction. The school serves 250 impoverished children who cannot afford to attend government schools. Although the schools is not completely finished, they were able to move at the end of 2010 when they were evicted from the building they had been renting.

4c (Code:) (Expenses \$ 28,590 including grants of \$ 28,590) (Revenue \$ 0)

AYA expanded the farming operation to serve its Kenyan partners. The farm benefited from the purchase of a tractor and the purchase of 7 additional acres. Harvests of corn went to partner orphanages and schools and benefited over 4000 children through feeding programs.
